Present for the Union: Steven Austin, Bill Scutt, Larry Niece, Orv Glombowski, Jim Smith, Scott Larabel, and Michelle Flanagan.

- 1. Aisleways: Mike Warber presented a blueprint of entire downtown facility. Management and the Union will lay out lines for aisleways, and maintenance will put tape down.
- 2. Automation jobs at the Annex: Management does not want to "drain" downtown. As more zones go up on DBCS, some automation clerks may go with their jobs to annex.
- 3. More clerk jobs at the Annex: Once again, management does not want to "drain" downtown. Contractual issue.
- 4. Additional square footage at the Annex: No approval for additional funds as of yet.

- 6. Feeder tables in automation: They are built, they need to be painted.

- 15. Lack of proper equipment: Due to reclass, Jim Tennant is trying to get additional equipment from Kalamazoo, Flint Saginaw and Chicago. If regular equipment is not available, use an alternate piece of equipment. i.e. gaylords, hampers, u-carts.
- 16. Use of "Gaylords": Use safety precautions. May be cut in a "U" shape on one side, must be able to reuse and shrink wrapped.
- 17. 3971's not being handled expeditiously: MDO's will address.
- 18. Reclass: Taking transfers from Associate Offices, additional staffing is in "limbo" due to "with holding".
- 19. OT at the Annex: Lists will be posted on each tour, and in each station.
- 20. Associate Office PTF's able to work in Grand Rapids facilities to get their "40": Definitely yes. Let Marty know or Murry know.
