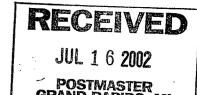

Old Business

- 1. Were there any questions or concerns regarding the May Labor/Management minutes? No questions or concerns regarding the May 2002 Labor/Management minutes.
- 2. Update on supervisor in CFS on weekends. Kim Peters to get with Mark Maciejewski. Kim addressed with Mark who addressed with Debra Anne Treamer and she stated that if no supervisor was working for any period of time, the employees were given directives to contact a specific Plant supervisor if needed.
- 3. Update on AO PTF's working in the Grand Rapids Installation. Casuals still getting more hours than PTF's.
 - All AO PTF's have been sent back to their respective offices. Management states that PTF's can be worked any time and anywhere. There are no pool clerks currently qualified at E. Paris branch.
- 4. Update on new building. Nothing new to report.

- 5. Clerks at Seymour Square Station told to work alone. Kim Peters is looking at changing hours at Seymour Square and other offices in GR. Kim will talk to Inspection Service and get back to Union. Positions will be looked at for possible abolishment at other offices in GR. Centerpointe and others.

6. Policy of replacing Union President when on extended leave.

Management will look into issue. Discussion on Union activities in general.

7. Mail found under DBCS.

Discussion on ways to find mail and assign duties to employees. John Peters will check with other offices to see how they address problem.

8 Contract drivers still not wearing proper ID at P-1.
