Officer's Report

<u>Treasurer's Report</u> was read for May 2008. Carried.

<u>President's Reports</u> Thank you everyone for coming. Wasn't sure if people would show up with such a beautiful day and warm weather activities. State Constitution Convention. Everything went

really well. There were some long-standing problems that we are beginning to get resolved. Seven presidents will be meeting (as I am one) to resolve the financial issues of the State. We have a copy of the Convention report and Resolutions book for those who wish to see what kind of work is done at the convention. There is a Retirement survey. There has been rumors going around regarding staffing changes at the P1 & P3. As of today, nothing has been discussed. We have a meeting on June 13th to discuss these. We are going to have a Stewards training this week. The Tigers have fell on their butts; and because of it we are having a hard time of filling the bus. If you know of anyone that would like to go to the game on June 29th, please send them my way.

Vice-President's Report: I redid the non-members list. We have a total of 118 non-members in the local. (51 clerks, 21 Maintenance, 8 in the Motor Vehicle, and 31 in the Associate Offices.. Jack has done a wonderful job organizing. We have stewards training on Tuesday (June 10th). We will be learning the Reassessment process. Job Summit –There are some errors with the last posting. There was one Manual job that was posted with split days that was pulled because the union was not in agreement with splitting the days. Successful bidders, pending qualification – there is an issue with them falling to the next bidder when the relinquish. We have been dealing with that. Overtime is scarce. Still waiting to speak with Phil Tabbita (at National) regarding the casual numbers. Bruce at P1, and I am watching to make sure casuals don't go into overtime. Remember, they don't go into overtime until after 40 hours, so if they stay later than you, it doesn't mean they are in overtime. Casuals can not be in a preferred duty assignments. I would like to thank all the members of the State Convention committee. Did a wonderful job. Would like to recognize the local members who were elected for state union positions: Jennifer Amos – Human Relations/Injury Compensation Director; Michael Long – Editor; Amy Puhalski – Area 9 Director; Karen Hodges – POWER Representative.

Clerk Craft Director: Mandatory Safety Talk regarding Cell Phones. Management is going to come down on employees who use them. We have discussed this with management that the employee's Cell Phones are their Emergency Line since management doesn't staff the actual emergency lines. Just be careful and don't be blatant using your cell phone. There are no Pay Phones at the Plant (either P1 or downtown), so everyone needs to use their cell phones. Badge control policy. Bulk Mail acceptance. There will be a retro-fit coming for Automation. Management states that we are over 13,000 window clerks. Management has agreed that if we can increase our numbers, we will staff all the APC with career clerks. To reduce the costs to the local, I have been working downtown.

Maintenance Craft Director: There is a lot going with the shifting of tours. Most of the changes that management is proposing is regarding Mechanized Staffing. Still have a lot of transfers coming into our crafts. Still hiring off the streets. I think all the new hires have joined the union. The Mechanized Staffing is still at higher level waiting for approval. Catherine and Tammy is doing a great job regarding the transfer of employees to our craft from other crafts and their seniority.

Associate Office Director: I have been in discussion with Lynn Pallas-Barber regarding the staffing of the APCs. Maintenance of this machine is a craft function. If casuals are being used, please let me know so I can file the appropriate grievances.
