With the local elections are now complete, I would like to thank the membership for their support and assure that the board will move forward with best interest of the membership. Thank you for all those who have ran.

Thank you to Linda Chandler, Ray Novakoski, Roy Bailey, Dan Quillin, Jack Fryling for your service to the local.

Dues Increase: \$.89 cents for careers and \$.86 Postal Support Employees with the recent Pay Increase on November 16<sup>th</sup>. This goes along with the 1.5 and 2.5 percent increase (respectively). PSEs do not receive Cost of Living, thus the additional 1.0%.

November 30<sup>th</sup> – December 27 – Exclusion Period for Penalty Overtime.

Open Season for FEHB open until December 9th.

Budget Committee will give their report tonight in accordance with the Constitution tonight.

DAS Award regarding Associate Offices. Back in October, we received notification of an award of Postmasters and OICs doing bargaining unit work. We received the award a year ago, but management didn't adhere to it; so Arbitrator Das stepped in and clarified it. Management has until December 6th to provide the information to the APWU and the award/money is coming. This is a National Dispute.

Michael Long is now doing the local website. Thank you to Jennifer Amos for doing it for many years.

Bid Notices on the websites. Currently – only the Grand Rapids Installation is on the site. We start receiving bid postings from Associate Offices, we will post those on-line as well.

On November 10<sup>th</sup>, USPS is putting window operations into Staples. APWU President Dimondstein has stated that if USPS continues, it must be staffed by USPS Career employees. National has asked its unions to address.

Management Changes – We have Greg Chanski back. Michael Blackport – Transportation; Brandy Lane – Sparta Postmaster; Chris Lloyd – Grant Postmaster; Ed Downs – Jenison Post Office.

PSEs conversions. The grievance has been filed and is pending at Step 3. The carriers that were converted have specific language in their contract to convert. We can hope that the 2015 new CBA that the language is put in their to convert.
