## Officer's Report

Treasurer's Report: Treasurer's report read ending August 31, 2016 read at the meeting. MSC to accept the report.

## President's Report:

Since June 2016 - Arbitration Advocate school. Thanks to the membership for sending myself, Michael Long, Micah Zakarzecki, Suzi Boyd. Was a grueling experience but everyone was glad they went.

Pre-Disciplinary/Investigative Interview - Make sure to ask for a steward. Management isn't going to give you one if you don't ask. This is also when an inspector might bring you in.

When someone is hired, they do a preliminary interview of your hiring application. After you are hired, the inspectors go through and scrutinize your application even more. There is no time limit for this either. We have had one person attempted to be fired after being at the Post Office over 20 years.

If anyone is looking for a job. PSEs and CCAs are up now for Grand Rapids.

Customer Service bidding process. We are having issues. I have requested a meeting with the Postmaster. Jobs that are residual are being posted. There are too many issues with what is going on now.

Prime Choice grievance - The fourth day of arbitration for the case is next week.

Holiday Temp for annuitants. Need to be signed up by September 11st.

Life Insurance Open Season – until September 30. If you choose to elect for Life Insurance.

You need to check to how much you will actually be paying. Especially if you are approaching 50+ there is a sharp increase.

New Contract. We have a new contract. I think we did well.

Wage Increase – Just got one. Retroactive will be coming in November. In November there is also a 1.3% increase.
